### 19/20.53 Apologies for absence

Apologies were received and accepted from Cllr Keeler and Cllr Sutton.

#### 19/20.54 Declarations of Interest

All Members are reminded that they must disclose any pecuniary or non-pecuniary interests they know they may have in items of business on the meeting's agenda and that they must do so at this point, or as soon as they become aware of the interest. #### 19/20.55 Public Question Time (Limited to 15 minutes)

The Member of Public present was a Member of Danbury Cricket Club (DCC). He spoke about DCC and cricket as a sport and thanked Danbury Parish Council for its support and help in turning around the issues with storage of the DCC's roller. He praised the new groundsman appointed to prepare cricket wicket this season and the difference this had made; the improvement had been commented upon by opposing teams. When questioned about grants available to Cricket Clubs, he advised that the grants available were mainly for clubs which have their own grounds. He also spoke about the fact that the DCC would now be able to play 20/20 games next season at Danbury. He advised Members that the team welcomes members from age 12 years and upwards, but members are currently mainly aged 20 years plus.

#### 19/20.57 Budget 2020-21

Members discussed at great length the budget proposal to be put forward to the Resources Committee for recommendation to full council for 2020-21. Whilst the Members were to agree the budget proposal as a whole to go forward to Resources Committee, there were two items where a decision was required to be voted on:

Cricket Rent re 20/20 Games: Cllr Mrs Chapman proposed that the fee per game be set at £38.50, Cllr Berlyn seconded the proposal; six Members voted for the proposal, one Member voted against the proposal.

RESOLVED: that the fee per 20/20 cricket game be set at £38.50

The Old Pavilion Refurbishment Works: Cllr Thombs proposed that £1,500 be put into 2020/21 ear marked reserves for this project; Cllr Mrs Chapman seconded the proposal, all Members were in agreement.

RESOLVED: that £1,500 be put into 2020/21 ear marked reserves for The Old Pavilion Refurbishment Project.

Budget 2020-21: Cllr Chesterman proposed that the budget proposal as discussed and agreed be put forward to the Resources Committee for recommendation to full Council for 2020-21; Cllr Mrs Hessing seconded the proposal, six Members supported the proposal, one Member abstained.

RESOLVED: that the budget proposal as discussed and agreed be put forward to the Resources Committee for recommendation to full Council for 2020-21.
