# 22/23.76 Neighbourhood Plan

Following discussion of the content of the Plan, during which all members noted how impressed they were with the level of detail, a list of amendments that had been suggested by members to the Steering Group prior to the meeting were reviewed and members were happy with the changes to the draft plan they had been issued with.

RESOLVED: that the engagement strategy as outlined at the meeting be approved, proposed by Cllr G Chapman and seconded by Cllr Keeler, all agreed

Mr Holland outlined the next steps taking the draft plan to final Referendum. Mr Holland left the meeting.

Following discussion, it was agreed to approve the draft plan to proceed to Regulation 14

RESOLVED: that the Parish Council approved the draft Neighbourhood Plan and agreed to proceed to Regulation 14 consultation, proposed by Cllr Armstrong and seconded by Cllr Berlyn, all agreed
