# 22/23.45 County Cllr John Spence

Cllr Spence provided the following update:

- As Deputy Lord Lieutenant of Essex Cllr Spence had supported the Lord Lieutenant in the huge amount of work as a result of duties relating to the recent passing of HM Queen Elizabeth II.
- There were costing concerns relating to adult care needs and longer hospital stays
- Covid vaccination roll out continues
- The housing of migrants was difficult
- The demand levels across health services were large
- The A414 Route based Strategy was being undertaken and he was waiting for a completion date; however, funding would still be needed once the remedial works identified as there a lot of conflicting demands
- Parking inspectors will be reviewing Penny Royal Lane
- The 4000+ proposed homes at Hammonds Farm are causing concerns to Danbury and Little Baddow regarding the potential congestion/impact on the roads
- Cllr Spence was happy to support the Mens Shed and Sustainable Danbury through the Locality Fund

There was some discussion regarding the Hammonds Farm proposal and the issues relating to housing and schooling for migrants, in particular with language and cultural issues. Cllr Spence noted that Bradwell B had been given approval to continue planning initial consultations and that national Grid were looking at pylons partially across Essex which as a national priority may by pass planning
